In 2014, more than 68,000 children fleeing violence in Central America and Mexico arrived alone in the U.S. and were placed in deportation proceedings. Despite the complexities of the U.S. immigration system and the enormous stakes involved, unaccompanied children are not provided counsel. Without counsel, they are often unable to effectively present their case in immigration court and can be returned to their home countries, where their well-being, or even their lives, may be in danger.
