RACIAL JUSTICE FORUM

Racial Justice and Intersectionality:

Perspectives from Black and Latina Women in Corporate America

The confluence of different identities can create overlapping and interdependent systems of inequity and discrimination. Studies have shown that it is harder for Black and Latina women to advance to leadership roles in corporate America, and a one-size-fits-all approach to advancing women often leaves women of color behind. While the killing of George Floyd has focused attention on racial injustice, the stories of Black women killed by police have often been ignored.


